DIRECTIONS:

MetGel should be applied either:

1. To the whole level surface of a shrub or tree stump IMMEDIATELY after cutting close to the ground. The gel will be drawn down into the roots system and prevent regrowth. Simply retreat any regrowth. Great for Ginger, Chinese privet, gorse, agapanthus, arums and other hard to kill plants. Ineffective on Solanaceae and grasses. Or:

2. Smeared onto the underside of a couple of leaves of most herbaceous weeds.

Metsulfuron, the active ingredient in MetGel may persist for some time in the soil and may to travel through damp soil in ground water. Take care using where you risk affecting desirable plants downhill. It decomposes most quickly in acidic conditions. Metsulfuron is slow acting and plants may take several weeks to show signs of dying. Treated plants should not regrow. Simply retreat any regrowth that does occur.

HANDLING, PRECAUTIONS & EOUIPMENT CARE

Use disposable nitrile gloves and overalls when applying MetGel. Work backwards through the weed infestation to avoid skin contact. Do not use during rainy periods to reduce the risk of runoff. In suitable conditions, the gel dries quickly on stumps forming a seal. Clean paste from the brush with a paper towel after use. Refill containers from bulk supply in a secure area away from water courses. Not to be used on or around waterways. Rinse water may be used in spray tanks.
